#### **Defining Health Disparity, Equity & SDOH**



#### Health Equity

- Attainment of the highest level of health for all people
  - Inequity denies access to the possibility of having optimal health

#### **Health Disparity**

- Particular, preventable differences linked to social, economic and/or environmental disadvantage preventing the opportunity to obtain optimal health
  - Metric to determine progress toward achieving Health Equity

#### Social Determinates of Health (SDOH)

- Conditions in which people are born, live, learn, work, play, worship & age
  - Affects overall health & quality of life

Connecting to SDOH	Increases ability to address non-medical issues to impact patient health
Reach Underserved Populations	Creates connections with those not engaged into the health system
Cost-effective Resourcing	Pools resources through partnerships to access health & social services
Strengthen Access to Data	Enhances access to data & information to direct strategy



- Extend education & training beyond classrooms & clinical experiences
- Cultivate inclusive learning environments in education & practice
- Intentionally recruit, support & mentor students of diverse backgrounds to reflect communities served
- ✓ Embed equity into AMA culture
- Build alliances & share power among historically marginalized physicians & stakeholders
- ✓ Ensure equity in innovation
- Foster pathways by amplifying marginalized narratives, quantifying past harms & embarking on transformative change
